

The contractors will be able to see the comparative statement online.
2. Bids will be opened as per single stage single envelope PPRA procedure i.e 36 (a) of PPRA Rules 2004.
3. Earnest money in the shape of call deposit of 2% of total tender amount in favor of Cantonment Executive Officer, must be accompanied.
4. The CDR will be returned to the successful bidder after six months.
5. The rates should be inclusive of FOR destination as well as all applicable government taxes.
6. Bidders will first register itself on ML&C E-tendering portal i.e <https://etender.mlc.gov.pk> for participating in the bid/quotation.
7. The quotation rates shall be valid for 02 months.
8. Successful bidder shall be bound to deliver the goods within fifteen days after receiving the work order.
