### TENDER NOTICE

Sealed quotations are invited / required from reputed Firms having registration with Sales Tax and Income Tax Department for Re-vamping / Re-designing of Shami Chowk with installation of Replica of Rohtas Fort monument (material to be used for monument other than fiber Glass) and allied works at Iftikhar Janjua Road Jhelum Cantt. The interested firms are required to submit their bids through SINGLE STAGE TWO ENVELOPES procedure as PPRA Rules, 2004. Each envelope shall contain separately, the TECHNICAL PROPOSAL & FINANCIAL PROPOSAL. The bid validity period shall be ninety (90) working days after the bid is received and opened.

#### EVALUATION CRITERION:

The evaluation committee of JCB shall first scrutinize the technical proposal based on evaluation criteria given in bid documents while retaining the FINANCIAL PROPOSAL. The mandatory documents required to qualify for bidding process are mentioned as under. However, additional documents in support of your bid may also be provided along-with.

- (a) Company profile with details of its establishment, relevant experience, HR & managerial capabilities required for the project.
- (b) Past performance / experience of similar nature of works.

#### FINANCIAL EVALUATION

Only short listed technically responsive parties/firms shall be called for opening of financial bid which shall be opened in the presence of parties/firms or their authorized representatives who wish to be present on the given date and time.

#### SUBMISSION OF TENDER:

1. Tenders to reach in the Office of Jhelum Cantonment Board, Address Tufail Road Jhelum Cantt is **on 27-04-2021 at 11:00 Am** and shall be opened on same day at **11:30 AM**. The tender received late will not be entertained.
2. Conditional tenders will not be accepted.
3. Only one tender should be included in one envelope. The outside of the envelope should be inscribed with Name of work and date of advertisement.

Tender documents can be obtained from the Office of the Jhelum Cantonment Board during the office hours on payment of **Rs. 2500/-** (Non Refundable) immediately after publication of this notice.

#### TERMS AND CONDITIONS:-

1. Each bid shall comprise one single envelope containing, separately, financial proposal and technical proposal.
2. The bidder/ supplier shall conduct complete survey at the sites for the purpose of Re-vamping/ Re-designing of Shami Chowk.
3. The quotation will be supported equal to 5% of the bid value in the form of CDR in favour of CEO Jhelum Cantt should be attached with the quotation as security.
4. The quoted rates should be inclusive of all taxes / levies imposed by the Government of Pakistan / Provincial Government independently.
5. The rates should be inclusive of all Freight on road to destination.


